Product

Product description:

1 m² installed plastic foil used as a barrier for radon radiation in construction with a technical lifetime of 60 years. Radon Barrier is used under the flooring of the building. DAFA Radon Barrier is manufactured at a production site in Finland and imported to Denmark for storage at two warehouse locations.

Radon Barrier is available in 400 and 500 μ m. The material composition of the 500 μ m is linear to its 400 μ m counterpart, with the exception of packaging which remains constant from the 400 μ m to the 500 μ m variant. Both product variants are included and reported on individually.

The 500 μ m variant targets the Norwegian market. This product is made specially to adhere to the SINTEF certification scheme that requires increased resistance to impact (primary and secondary) cf. EN 12691.

Product specification:

DAFA Radon barrier: A barrier that ensures effective airtight radon and moisture-resistant seal. The DAFA Radon barrier is suitable for installation in most types of heated buildings, such as homes, offices, etc. The barrier is used to reduce and mitigate the naturally occurring ingression of radon from the ground into the building. DAFA Radon Barrier is manufactured through an extrusion process.

Data quality:

Product specific data is delivered by DAFA Building Solution A/S. Product-specific data is sourced from the production site located in Finland, and two warehouses located in Denmark. Generic data is from Ecoinvent 3.8 (2022) "Allocation cut-off by classification". Product-specific data is representative of the year 2021 and was collected in 2022.

Allocation:

Allocation is done in accordance with the provisions of EN 15804+A2. Allocation of energy, water, and waste from production is calculated by a physical allocation factor based on the manufacturer's input. For waste produced at the manufacturing, the benefits for reuse, recycling and recovery are allocated by using this allocation factor.

System boundary:




Figure 1: Modules covered in the EPD

Figure 1 shows the system boundaries for the analysis. The analysis is a cradle-to-gate, with module options A4, A5, C1, C2, C3, C4, and D. Note: the boundary around A1 indicates processes tied to the production in Finland.

Cut-off criteria:

The general rules apply for the exclusion of inputs and outputs in the LCA which complies with 15804:2012+A2:2019. 6.3.6. In cases of insufficient input data or data gaps for a unit process, the cut-off criteria shall be 1 % of renewable and non-renewable primary energy usage and 1 % of the total mass input of that. The total neglected input flows, e.g., per module A1-A3, A4-A5, and B1-B5, B6-B7, C1-C4 and module D shall be a maximum of 5 % of energy usage and mass.

All major raw materials and all the essential energy is included. This cut-off rule does not apply for to hazardous materials and substances. The following processes and materials have been excluded based on specified cut-off criteria.

LCA: Scenarios and additional technical information

Product stage (A1-A3)

Module A1 is the manufacturing of DAFA Radon Barrier at the production site located in Finland. DAFA Radon Barrier is manufactured from petrochemical-based virgin polyethylene. DAFA Radon Barrier is manufactured through an extrusion manufacturing process. Packaging of the product is performed at the production site, where the product is rolled onto a cardboard core, and wrapped in packaging film. Raw materials are sourced from within or near Finland with an average transport distance of 500 km. Production in Finland is based on the certified renewable electricity mix and utilize excess heat generated during production for facility heating

Module A2 is transport of DAFA Radon Barrier by truck from the production site located in Finland to DAFA's two warehouse sites in Denmark. Transport data is applied based on communication with suppliers.

Module A3 is DAFA's own warehouse activities This includes water, electricity, and heatingrelated activities. DAFA Radon Barrier is stored at two warehouses in Brabrand and Stilling, in Denmark. The Danish residual electricity mix is applied for DAFA's own activities. DAFA Does not alter the structure, or packaging of the product once received in Denmark.

Installation (A5)

The installation of the vapor barrier results in a 10% product loss, which is considered when fulfilling the declared unit of 1 m2. Furthermore, tape and staples are needed for the installation.

End of Life (C1, C3, C4)

The product contributes marginally to C1 and has been included in cut-off. This is because s limited handling is performed during the demolition/dismantling of a structure. The following waste scenario is applied based on national waste statistics for the building sector. Waste sent to recycling is 50.4%, waste sent to energy recovery is 45.4% and waste sent to landfill is 4.2%.
